**Local Rule Regarding  
Information Needed for Participants to Participate in Proceedings**

---

**Section 1. Authority**

Pursuant to Rule 21(b) of the Texas Rules of Civil Procedure, the Court adopts this Local Rule to provide the required information for participants in proceedings before the Atascosa County Court at Law and proceedings assigned to the Atascosa County Court at Law Judge.

**Section 2. Mandatory Service of Court Proceedings**

**(a) Required Contents of Notice**

Under Texas Rule of Civil Procedure 21(b), notice of any court proceeding must state:

1. The location of the proceeding or instructions for joining electronically;
2. The Court's contact information;
3. The date, time, and type of proceeding; and
4. Instructions for submitting evidence.

**(b) Failure to Serve Proper Notice**

Failure to provide proper notice, as required by this Section and Rule 21(b), may result in the Court cancelling the proceeding, resetting the proceeding, or dismissing a participant's pleadings for want of prosecution.

**Section 3. In-Person Proceedings**

**(a) Location**

Unless otherwise ordered, in-person proceedings are held at the Atascosa County Justice Center, 1405 Campbell Avenue, Jourdanton, Texas, in the County Courtroom.

**(b) Court Contact Information**

830-769-4232.

**(c) Evidence**

1. Testimony is presented in person.
2. Documentary evidence, photos, or videos must be labeled and shared with the opposing participants.
3. Video evidence must be submitted on a USB device.

**(d) Notice Language**

Suggested language for notices of in-person proceedings is provided in Appendix A.

#### **Section 4. Zoom Videoconference Proceedings**

##### **(a) All Proceedings Presumed In Person**

Unless the notice states otherwise, participants appear in person.

##### **(b) Videoconference Appearance**

The Court may order participants to appear by Zoom. Some participants may be required to appear by Zoom while others appear in person.

##### **(c) Zoom Meeting Information**

##### **(d) Court Contact Information**

830-769-4232.

##### **(e) Technical Requirements**

Participants must create a free Zoom account at [www.zoom.us](http://www.zoom.us) and use a device with audio, video, and stable internet.

##### **(f) Methods of Participation**

1. **Desktop/Laptop:** Enter the meeting number in the Zoom app.
2. **Smartphone/Tablet:** Download the Zoom app before the hearing; open the app and enter the meeting number.
3. **Telephone (only with Court approval and if no internet access):** Dial 346-248-7799 and enter the meeting number.

##### **(g) Evidence**

1. Testimony is presented live on Zoom.
2. Exhibits must be submitted via the Zoom “chat” feature.
3. Exhibits must also be labeled and emailed to opposing participants by 3:00 p.m. on the business day before the proceeding.
4. Physical evidence will not be accepted.

##### **(h) Notice Language**

Suggested language for notices of Zoom proceedings is provided in Appendix B.

#### **Section 5. Compliance**

Failure to comply with this Local Rule may result in sanctions, including exclusion of evidence, denial of participation, or contempt. Failure to provide proper notice, as required by Section 2 and Texas Rule of Civil Procedure 21(b), may result in the Court cancelling the proceeding, resetting the proceeding, or dismissing a participant’s pleadings for want of prosecution.

Participants shall submit testimonial evidence by giving oral testimony while physically present in the courtroom. Participants shall submit any physical evidence, documents, photos, or audio/video in person to the court. Participants shall properly label and provide the opposing participants with copies of all the documents, photos, or audio/video files they intend to submit as evidence during the court proceeding. Participants shall submit any digital media evidence stored on a USB flash drive or an optical storage device that complies with Technology Standards approved by the Supreme Court.

Participation in the Zoom videoconference court proceeding may be through any of the following methods:

1. Desktop/Laptop: To join the Zoom videoconference court proceeding, input the above Zoom meeting number into your Zoom software or application a few minutes before the Zoom videoconference court proceeding start time.
2. Smart phone or tablet: Prior to the court proceeding date you must download the Zoom Meeting app. to your device. A few minutes before the Zoom videoconference court proceeding start time, open the Zoom app. and enter the Zoom meeting number above to join the Zoom videoconference court proceeding.
3. Phone Call: (only if no internet access is available and if the judge allows) To join the Zoom videoconference court proceeding by a land line, call 346-248-7799 and input the Zoom meeting number when prompted.

Participants shall submit testimonial evidence by appearing and giving oral testimony in the Zoom videoconference. Participants shall submit any documentary evidence, photos, or videos through the "chat" feature of the Zoom videoconference. Not later than 3:00 p.m. the business day before the Zoom teleconference court proceeding, participants shall properly label and email to the opposing participants all the documentary evidence, photos, or videos they intend to submit during the court proceeding. Participants cannot submit physical evidence during a Zoom videoconference.
